INTRODUCTORY NOTE:

ICGEB is an international organization dedicated to advanced research and training in molecular biology and biotechnology, with special regard to the need of the developing world. ICGEB, New Delhi Component has been given privileges and immunities as for other UN Organizations in India vide Government of India's gazette notification no. 216, SO 403(E) dated 12 April 1988.

ICGEB invites sealed Bids to meet the immediate requirement for "Comprehensive Maintenance Contract (CMC) of Sound & Lighting System" Interested & competent firm/individual may download the Bid documents from ICGEB website

Submission of Bid:

1. Documents comprising Two Bid (Technical Bid & Price Bid). Tender should be submitted in two Parts separately i.e. "Technical bid" (Part-A) and "Price bid" (Part-B).

2. Technical Bid (Part-A) : In this bid, the Bidder should submit his company profile and structure of firm, name of directors/partners/proprietor as per the Annex 1.

3. The following are minimum essential for technical qualification:

- a) Copy of work orders for "Supply of Similar Purity Gases" successfully executed during the
- b) last 2 years for reputed Public Ltd. Companies, Public Sector, Govt. Institutions and Autonomous bodies.
- c) Copy of Certificate (s) of compliance /analysis for the quoted gas
- d) Copy of GST Registration Certificate.
- e) The Bidder shall submit Annex 2 as a token of tender acceptance of the Tender conditions.

4. Price Bid / BOQ (Part-B): In this bid, the Bidder is required to quote his prices as per BOQ. The Bidders should quote unconditional rates in the Price bid section.

5. Validity of Tender: Tender shall be valid for our acceptance without any change in rates and NIT conditions for a period of 180 days from the date of opening of price bid.

6. Escalation: No escalation shall be paid during the execution of contract period except any variation in Raw Material cost with proof of documents for the raw material buying cost.

7. Terms of Payment: 100% payment for the supply of materials shall be made on bill basis normally within 30 days against delivery after the same are checked

8. Tender rejection: ICGEB, reserves the right to reject any or all the tenders in full or in part without assigning any reasons whatsoever, and the decision of the authority in this regard will be binding on all the Bidders. Tender not complying with any of the provisions stated in this tender document are liable to be rejected. The TENDERING AUTHORITY reserves the right to accept any bid, not necessarily the lowest, reject any bid without assigning any reasons for entering into the Rate Contract.

SCOPE OF WORK AND SPECIAL CONDITIONS

- 1. The quantity mentioned above is the total annual required estimated quantity. The same was the requirement of the lab for previous year. The quantity mentioned in the tender can be increased or decreased to any extent depending upon the actual requirement, in which case, the Bidder has to effect supply of the revised quantity at the quoted rate itself.
- 2. The successful Bidder shall collect the empty cylinders within 24 hours of intimation by ICGEB Stores on phone/email etc and filled cylinders shall be delivered to ICGEB Stores, by next day or as per ICGEB delivery instruction.
- 3. Empty cylinders shall be taken from lab after obtaining gate pass for the same issued by ICGEB _ Stores and signed by both the parties. Bidder shall give the empty cylinder receipt against each
- 4. cylinder. Filled cylinders shall be returned along with proper Bidder's challan. Defective cylinder, if any supplied must be taken back and be replaced with no additional cost.
- 5. DELIVERY SCHEDULE: Non-availability of the stock should be informed in writing immediately.
- 6. ICGEB laboratory may ask for the gas purity certification / test from third party from time to
- 7. time. The cost for same shall be borne by the successful Bidder.
- 8. The unit price and GST Rate shall be quoted for each gas. The prices shall be inclusive of charges for gas, cylinder processing if any, loading / unloading, handling charges and labor charges etc.
- 9. The rates quoted shall be valid and firm for three years. So that ICGEB shall have the option to extend the terms of this contract for an additional period as mutually agreed, with the same terms and conditions for a maximum of three years. No escalation in rates will be provided except changes in Raw material cost or any exceptional condition may arise. ICGEB is entitled to place supply orders up to the last day of the validity of the rate contract and, though supplies against such supply orders will be effected beyond the validity period of the rate contract, all such supplies will be guided by the terms & conditions of the rate contract
- 10. Rates shall be quoted for all the items. Price bid with partially filled rates shall be liable for rejection.
- 11. The amount quoted for all items shall be valid for Three years (from the date of issue of contract), and the contract tenable to further extension upon mutual agreement. Once the Rate Contract issued, there shall not be any deviation in price and quality from the initial quotation offer. Any deviation from the initial agreement may invite quick termination of the said contract, without further notice. The party will be blacklisted and will not been considered thereafter.
- 12. Quantity mentioned is estimated. Payment will be made on actual supplied quantity only.
- 13. Transit Insurance Clause: The purchaser will not pay separately for transit insurance and the supplier will be responsible till the entire stores contracted for, arrive in good condition at destination. The transit risk in this respect may be covered by the supplier by getting the stores duly insured, if he so desired. The supplier in his own name and not in the name of consignee shall obtain the insurance cover.
- 14. REPLACEMENT OF REJECTED GAS CYLINDER(S): The rejected item due to the deviation from the desired quantity or quality should be replaced within 48 hours from the date of issue of Rejection Notice. If rejected item is not replaced within the said period, ICGEB has the right to levy LD clause for the particular item.
- 15. If ICGEB"s cylinders are given for refilling same shall be returned in filled condition at the earliest. In such condition cylinders shall not be exchanged/replaced with any other cylinder(s). However, Bidders are liable to done mandatory periodical test(s)/ replacement of accessories in the above cylinder as per the rates quoted in the tender during the contract time and documents should be submitted on case by case basis.

- 16. In case of unavailability of ICGEB"s cylinder(s), the supplier has to supply the gases in their own cylinder(s); the same (empty cylinder(s)) will be returned back by the lab only after its complete usage. Those who supplied cylinders shall make necessary arrangements to take back their empty cylinder(s) from the concern laboratory of ICGEB without any additional cost.
- 17. Qualified Bidders shall have their own office / godown in and around ICGEB (not beyond 100 km). However, if any far away Bidder agrees to supply cylinders within the stipulated date in any time without any additional cost and delay may be considered on trail basis initially, and further orders will be based on their service or the need of the lab.
- 18. Penalty: In case of any delay in delivery of refilled cylinders beyond stipulated date, Bidder is liable to pay penalty @ Rs.200/- per day per cylinder till the date of supply of required number of cylinders. Such penalty will be deducted from the outstanding invoice/payment Performance submitted by the party.
- 19. All cylinders are required to be examined/ tested periodically as per the Gas Cylinder Rules, 1981. Responsibility for compliance with this rests with the Vendor, who will carry out test as may be required.
- 20. All gas cylinders are required to be painted as and when necessary to the appropriate colour –code specified in the Gas Cylinder Rules, 1981. Responsibility for compliance with this rests with the Vendor, who will carry out test as may be required
- 21. All gas cylinders such as CO2, O2, Helium, Mix gas, Nitrogen, Argon, hydrogen, etc, must come with a hydraulic test verified in each cylinder. A sticker should be pasted on the cylinder with validity or expiry date and the next due date of the hydraulic testing.
